Subject: Sixty SC/ST students from Bihar forced to leave REC, Bhuvneshwar due to non-payment of stipend under State Govt's Dalit Stipend Scheme.

Case of : Motihari & Bettiah Districts.

BHRC takes suo motu cognizance of news report published in Times of India, Patna edition today (02.02.2016) captioned "60 Dalit students from Bihar threaten suicide: Students Forced to Leave Bhubneswar College".

2. According to the report, 60 SC/ST students from Bihar (18 from East Champaran and 42 from West Champaran) were forced to leave **Rajdhani Engineering College (REC), Bhubneswar** after the Bihar Government failed to pay their stipend despite repeated request by the college administration. Reportedly, these students had secured admission in the college in 2014 under **State Government's "Dalit Stipend Scheme"** and since 1 ½ years, stipend has not been sent to the college. It is reported that the proposal sent by the District Welfare Officer, East Champaran is pending with the SC/ST Welfare Department, Government of Bihar since June 2015.

3. Issue notices to the (i) **Principal Secretary, SC/ST Welfare Department, Government of Bihar** (ii) **District Welfare Officer, East Champaran**, & (iii) **District Welfare Officer, West Champaran to file their reports to the Commission by 18th February 2016**. A copy of the newspaper clipping be also sent along with a copy of this order.

4. The case be listed on 22nd February, 2016.

60 dalit students from Bihar threaten suicide

Students Forced To Leave Bhubaneswar College

Motihari: Sixty dalit students from Bihar studying at Rajdhani Engineering College (REC). Bhuneswar, were forced to leave the college and their respective hosels on January 8 after the Bihar overnment allegedly failed to ay their stipend despite repeated equests by the college dministration.

These second year students hathreatened to commit suicide if e government failed to come to elr rescue.

The 60 dalit students - 18 from ist Champaran and 42 from West iamparan - secured admission the college in 2014 under the stagovernment's Dalit Stipend neme. They alleged that the Bigovernment had last paid the yend to the college one and af year ago.

"We have decided to commit cide because our future is at re due to negligence of SC/ST "are department of the Bihar ernment," said one of the stus, adding that the college cipal has asked them to re-

turn only when all their dues are cleared. According to a joint press release signed by four students of REC – Loknath Kumar, Gajendra Kumar, Mukesh Kumar and Ujjawal Kumar – the college that falls under under Biju Patnaik Technical University provided them free education, boarding and lodging for more than a year. "In 2015, Bihar government did not send stipend to the college," said the joint press release.

"We even met Ashok Kumar Nagbansi, the district welfare officer of East Champaran, and urged him to send the stipend to the college, but to no avail." they said Nagbansi, on his part, said he

had sent the list of 16 dalit students of East Champaran who are studying at REC. Bhubanessar to the SC/ST welfare department on June 6, 2015, urging it to transfer the stipend to the college. He said the SC/ST welfare department is authorized to send the stipend of dalit students to their respective colleges. The district welfare department only examines the college records and documents of the students, "Naghanst added.

Principal secretary of SC/ST welfare department SM Ratu said the government usually makes no delay in sending the stipend of dalit students to their respective colleges in other states. "If REC, Bhubaneswar, has forced the students to herve college, we will look into the matter," he added.

Basudeo Ram, father of Loknath Kumar, met Raju in Patna on January II with the help of Manju Devi, chairperson of East Champaran Zila Parishad, and requested him to send the stipend. "The principal secretary has assured us that the money would be sent soon," a visibly concerned Ram said.
