Judgement & Order

Sh. Manoj Kumar, Joint Secretary, Bihar Staff Selection Commission, Patna is present today before the Commission. Heard him.

2. Complainant Jugnu Kumar, candidate aspiring for passed Assistant Section Officer with the State Government has filed this complaint. He alleged that he appeared for preliminary Test conducted by the Bihar Staff Selection Commission, Patna with Preliminary Test Roll No. 10765776 and passed that examination. Subsequently he appeared for Mains Examination on 23.01.2023 with allotted Roll No. 310920 and has cleared that examination also. That is how his name was recommended for appointment to the post of Assistant Section Officer by the Bihar Staff Selection Commission, Patna.

3. However, to his surprised he noted that in the recommendation list as against his Roll No. 310920, name of one Rakesh Kumar was mentioned. The complainant was driven out

during the counselling. He has therefore, sought action against the erring Officer. The complainant has placed on record Photo Copies E-Admit Card of Preliminary Test as well as Mains Test. He has also placed on record other documents regarding the selection process.

4. Upon noticing , the Bihar Staff Selection Commission, Patna has filed detailed reply along with all documents including photo copies of the Admit Card, E-Attendance Sheet, Biometric Verification record and OMR Sheets of the concerned candidate's.

5. Sh. Manoj Kumar, Joint Secretary of the Staff Selection Commission has personally tender the report along with the documents. He is present before the Commission. He states that the complainant needs to be prosecuted for the offence of forgoing by lodging the F.I.R.

6. I have carefully considered the entire record submitted by the complainant and also on behalf of the Staff Selection Commission.

7. Record of the Bihar Staff Selection Commission unerringly points out that claimed that Preliminary Test Roll No.




10765776 was earmarked to the candidate named Indra Mohan whereas Roll No. 10765715 was allotted to complainant Jugnu Kumar. Record of the Selection Commission shows that complainant Jugnu Kumar who had appeared for the Preliminary Test with Roll No. 10765715 had not passed that Preliminary Test. The Attendance Sheet and Admit Cards of the Selection Commission goes to show that complainant Jugnu Kumar had appeared in the Preliminary Test with this Roll No. 10765715. The photo copy of the E-Admit Card for Preliminary Examination mentioning Roll No. 10765776 as his Roll Number for the Preliminary Test by the complainant is apparently forged documents may be created by use of PhotoShop technique. Similarly record of the Selection Commission makes it clear that Photo Copy of the E-Admit Card mentioning Roll No. 310920 for Mains Examination showing name of complainant Jugnu Kumar thereon is also forged document may be created by PhotoShop technique. These prima facie conclusions are drawn because record produced by the Bihar Staff Selection Commission, Patna showing that Roll No. 10765715 for Preliminary Examination was

allowed to candidate name Indra Mohan who had cleared the said examination on this Roll Number. Record of the Bihar Staff Selection Commission, Patna further makes it clear that Roll No. 310920 for Mains Examination was allotted to the candidate named Rakesh Kumar who has cleared the Mains Examination. The Selection Commission has placed on record the Photo Copies of these documents of these candidates including their Attendance Sheets and Admit Cards. The record of the Commission nowhere shows that the complainant Jugnu Kumar appeared Preliminary Examination on Roll No. 10765776 or Mains Examination on Roll No. 310920. Biometric verification record, the Photo Copy is placed on record shows that Roll Number for Mains Examination 310920 was allotted to Rakesh Kumar who appeared for the said verification.

8. The complaint as such is not only devoid merit but it is motivated complain filed by using forged and PhotoShopped documents. The authority aggrieved by this act of the complainant is certainly the Bihar Staff Selection Commission and said authority can initiate appropriate legal action against the

complainant including lodgement of the F. I. R. This observation shall not be treated as concluding anything adverse qua the complainant for initiating legal action as stated by the Selection Commission. Ultimately it is for the Investigating Officer to unearth the truth regarding the photo copies of the documents as such, E-Admit Card for the Preliminary Examination and E-Admit Card for the Mains Examination placed on record by the complainant for claiming relief. In this view of the matter, the complaint is closed.
