Sub: Launching of sensitization programmes at district level in Bihar

It is our firm belief that adequate sensitisation of public servants goes a long way in minimising human rights violations or failure to prevent such violations by the public servants. It has, therefore, been decided that in order to give further momentum to the BHRC efforts for sensitisation of public servants in the state, **Secretary, BHRC and IG, BHRC will jointly conduct four district level sensitisation work shops every month.**

2. The workshops shall be attended by:-

- (a) District Magistrate,
- (b) Superintendent of Police,
- (c) CMO-cum-Civil Surgeon,
- (d) Sr. Executive Magistrate/Police Officers/District Commandant, Home Guards,
- (e) BDOs, COs & SHOs,
- (f) Officers related with Jail Administration, Reformation and Remand Homes,
- (g) Officers related with hospital administration;
- (h) Assistant Director, Social Security and District Account Officers (retiral dues clearances),
- (i) District Education Officers/District Superintendent of Education/Persons related with educational institutions;

(j) Agencies working for the upliftment of children, differently abled persons, Women, SC, ST and other weaker sections of the society, Red Cross (Incharge of District Disability Rehabilitation Centres)/ representative of Pensioners Associations,

(k) Officers of Energy, Agriculture, Animal Husbandry & Fisheries, Forest, Minority Welfare, Food & Civil Supplies, Rural Developments, Rural Work, Urban Development, Panchayati and Labour Resource & Cooperative Department, (I) Officers of Gramin Bank and related agencies,

- (m) Other officers considered relevant by the District Magistrate.
- 3. **NGOs** and members of **Media** should be associated with the workshops and their assistance sought in highlighting various issues.
- 4. Needless to say that minimal financial assistance/support from BHRC should be extended to the District Magistrates in organizing such workshops.
