The contract period is effective from the date of awarding the contract to 31.03.2017.

The agency putting up the quotation should have minimum five (5) years of experiences in carrying out similar work.

I. Terms & Condition:

- (a) The make and model of the above mentioned commercial vehicles should not be earlier than 2007.
- (b) All the vehicles must have valid permit to run in the territory of Bihar.
- (c) The vehicles shall be kept neat and clean and in perfect running condition and should be provided with basic amenities.
- II. Contract Price:
 - (a) Quotations should be submitted on the letterhead of the bidder in the format provided with this letter (Annexure-I). Corrections, if any, shall be made by

- (b) All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- (c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subjected to adjustment on any account.
- (d) The prices should be quoted in Indian Rupees Only.
- (e) Each bidder shall submit only one quotation.
- (f) The Contract period is only for One Year. The contract may be extended beyond one year based on the performance of the firm.

III. Bidder has to submit following documents along with the quotation

- (a) Copy of the registration with Tourism Dept. of Govt. of India/ State Govt.
- (b) Copy of Service Tax Registration Certificate.
- (c) Copy of Income tax return for the last two years.
- (d) Copy of PAN Card.
- (e) Document in support of the past performance.
- (f) The Bid should accompany a DD/ Pay Order of Rs. 10,000/- (Rupees Ten thousand only) drawn on and nationalized Bank in the Name of Deputy Secretary, Bihar Human Rights Commission, Patna payable at Patna towards Earnest Money Deposit (EMD).

IV. Service:

Provision of registered commercial vehicles (Taxi) with licensed drivers, on hiring basis for running in Bihar.

V. Validity of Quotation:

Quotation shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

VI. Evaluation of Quotation:

The purchaser shall evaluate and compare the quotation determined to be substantially responsive i.e. which

- (a) Are properly signed; and
- (b) Conform to the terms and conditions, Eligibility Criteria and specifications.
- (c) Quotation will be evaluated separately for each commercial vehicle.

VII. Award of Contract:

BHRC will finalize the rate contract of the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

 (a) Notwithstanding the above, the purchaser reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations any time prior to the award of the contract (b) The bidder whose bid is accepted will be notified of the award of the contract by the purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

VIII. Payment:

No advance payment will be made. Payment will be made after submission of the bill along with the certification by the competent officer who utilized service of vehicle.

IX. Submission of Bid:

The last date and time for submission of the completed bid is 04.00 PM on 9th March 2016.

X. Tender Opening:

The bid will be opened on the last day of submission of bid (i.e. on 14th March 2016) at 04.00 PM in presence of the bidders of their authorized representatives who choose to attend.
